EBARA ELLIOTT ENERGY WEBSITE PRIVACY POLICY

This Privacy Policy covers Elliott Company, a Delaware corporation, and its subsidiaries, and Ebara Elliott Turbomachinery Corporation, a Japanese corporation, and its subsidiaries (collectively, "Ebara Elliott Energy").

Ebara Elliott Energy is committed to safeguarding your privacy online. This Privacy Policy covers information Ebara Elliott Energy collects on Ebara Elliott Energy websites ("Sites"), which could potentially be used to identify an individual ("Personal Information").

VISITOR'S CHOICE

Ebara Elliott Energy does not require visitors to provide all of the Personal Information listed below in order to use the Sites. If, however, you elect NOT to provide certain Personal Information, your ability to use all of the Sites' features will be limited, or you may not receive the information you have requested.

PERSONAL INFORMATION COLLECTION

Ebara Elliott Energy collects Personal Information that you provide to Ebara Elliott Energy when interacting with the Sites. Specifically, if you contact Ebara Elliott Energy through its Sites (e.g., submit a general inquiry or otherwise request information), you will be asked to provide your name, company, office location, telephone number and email address for the purposes detailed below.

Ebara Elliott Energy also automatically collects information about how visitors interact with Ebara Elliott Energy's Sites and their browsing habits, in order to provide a personalized user experience. The information collected depends on the pages visited and includes the name of the domain and host from which the visitor accesses the Internet; the Internet protocol (IP) address of the visitor's computer; the type of browser and software operating system the visitor uses; the date and time the visitor accesses the Sites; and the Internet address of the website from which the visitor linked to the Sites.

USE AND DISCLOSUREOF PERSONAL INFORMATION

Ebara Elliott Energy uses the Personal Information collected on its Sites (whether submitted by visitors or automatically collected) in order to:

- Conduct Ebara Elliott Energy's business, including providing you the products or services you requested
- Send you marketing communications about new or updates to Ebara Elliott Energy's existing products and services
- Comply with legal obligations and enforce Ebara Elliott Energy's legal rights
- Maintain and improve the Sites and tailor the visitor experience
- Protect the security of you, Ebara Elliott Energy, and the Sites

Ebara Elliott Energy shares Personal Information with its global affiliates, sales representatives, and service providers for the purposes described in this Privacy Policy. Ebara Elliott Energy also discloses Personal Information about you: (i) if Ebara Elliott Energy is required or permitted to do so by law or legal process; (ii) to law enforcement authorities or other government officials as required to comply with a legitimate legal request; (iii) when Ebara Elliott Energy believes disclosure is necessary to prevent physical harm or financial loss or to protect Ebara Elliott Energy's rights or property or the rights of another person, or in connection with an investigation of suspected or actual illegal activity; or (iv) in the event Ebara Elliott Energy sells or transfers all or a portion of its business or assets as part of a merger, sale, or acquisition. Ebara Elliott Energy does not sell or otherwise disclose Personal Information about its visitors.

Some jurisdictions require an explanation of the legal bases for Ebara Elliott Energy's collection and use of visitors' Personal Information. Ebara Elliott Energy has several different legal grounds on which it collects and uses Personal Information, including: (i) as necessary to perform a transaction (such as in order to provide the products or services you requested); (ii) as necessary to comply with a legal obligation (such as when Ebara Elliott Energy uses Personal Information for record keeping to substantiate tax liability); (iii) consent (where you have provided consent as appropriate under applicable law, such as for direct marketing); and (iv) necessary for legitimate interests (such as when Ebara Elliott Energy acts to maintain its business generally, including maintaining the safety and security of the Sites).

OFFLINE COLLECTION OF PERSONAL INFORMATION

Ebara Elliott Energy obtains Personal Information about individual contacts of its suppliers and customers in connection with the provision or receipt of products or services. That Personal Information includes: name, contact information, employer, title, credentials, associations, relevant products or services, and information needed for restricted party screening to confirm Ebara Elliott Energy can conduct business with suppliers or customers (which Ebara Elliott Energy collects via separate notice), all of which Ebara Elliott Energy uses to administer the business relationship and for direct marketing purposes. Ebara Elliott Energy uses Personal Information collected offline consistent with this Privacy Policy, specifically, the details in this Privacy Policy about how Ebara Elliott Energy discloses, secures, transfers, and retains Personal Information, the choices to optout of Ebara Elliott Energy's direct marketing communications, and how you may contact Ebara Elliott Energy with any questions or to exercise certain rights to your Personal Information.

COOKIES

Ebara Elliott Energy uses and allows certain trusted partners to use cookies, web beacons, and similar tracking technologies (collectively, "cookies") on its Sites.

What are cookies?

Cookies are small amounts of data that are stored on your browser, device, or the page you are viewing. Some cookies are deleted once you close your browser, while other cookies are retained even after you close your browser so that you can be recognized when you return to a website. How does Ebara Elliott Energy use cookies?

Ebara Elliott Energy uses cookies to provide the Sites and services and gather information about your usage patterns when you navigate the Sites, in order to enhance your personalized experience, and to understand usage patterns to improve its Sites and services.

Cookies on Ebara Elliott Energy Sites are generally divided into the following categories:

- **Strictly Necessary Cookies:** These cookies are required for the operation of Ebara Elliott Energy Sites. They include, for example, cookies that enable Ebara Elliott Energy to provide its Sites.
- Analytical/Performance Cookies: These cookies allow Ebara Elliott Energy to recognize and count the

CHILDREN

CROSS-BORDER TRANSFERS

Ebara Elliott Energy transmits the Personal Information Ebara Elliott Energy collected on the Sites to sales representatives, global affiliates, and service providers in the United States or other countries where Ebara Elliott Energy does business that are outside your home country, and may have different standards of data protection than your home country. Ebara Elliott Energy provides appropriate protections for cross-border transfers as required by law, including information transferred to third parties. With respect to such transfers from the European Economic Area ("EEA") to the United States and other non-EEA jurisdictions, Ebara Elliott Energy relies on European Union ("EU") Model Clauses and Binding Corporate Rules and/or the need to process your information in order to provide the requested services (e.g., performance of a contract) to transfer your Personal Information. As permitted by applicable law, you may request details about the suitable safeguards Ebara Elliott Energy has in place by contacting Ebara Elliott Energy as described below.

PROTECTION OF YOUR INFORMATION

Ebara Elliott Energy is committed to protecting your Personal Information submitted to it through its Sites. Ebara Elliott Energy maintains appropriate administrative, technical and physical safeguards to protect against unauthorized disclosure, use, alteration or destruction of the Personal Information you provide on its Sites. Ebara Elliott Energy also employs reasonable technologies to help keep the Personal Information you provide on its Sites secure.

Ebara Elliott Energy typically retains Personal Information related to marketing activities for as long as you accept marketing communications from us, and upon request, Ebara Elliott Energy will securely delete such Personal Information in accordance with applicable law. For Personal Information that Ebara Elliott Energy collects and uses for other purposes described above, Ebara Elliott Energy typically retains such Personal Information for no longer than for the period necessary to fulfil the purposes outlined in this Privacy Policy and as otherwise needed to address tax, corporate, compliance, litigation, and other legal rights and obligations.

As permitted by applicable law, you may have the right to obtain confirmation of the existence of certain Personal Information relating to you, to verify its content, origin, accuracy, as well as the right of access to, or right of review, anonymization, portability, or deletion, or to block or withdraw consent to the use of certain Personal Information, by contacting Ebara Elliott Energy as detailed below. Please note that Ebara Elliott Energy may need to retain Certain Personal Information for recordkeeping purposes, to complete any transactions that you began prior to your request, or for other purposes as required or permitted by applicable law.
